Kernville Rodeo Stampede -- August 30 & 31, 2007 Waiver Agreement

This is a release. It says I recognize I will participate in a Rodeo where risk is natural. Accidents, though rare, can happen. And, understanding this possibility, I expressly assume all risk in my participation and, if I get hurt or die or damage belongings, I will not make a claim, sue, or expect any legal responsibility from the Kernville Chamber of Commerce and/or its officers, directors, or its associates and affiliates of any capacity, involved with this Rodeo (collectively referred to in the following as "Kernville Chamber").

I understand that a Rodeo naturally involves risks such as slips and falls, which can result in accidents. As well, encounters with livestock, vehicles, or even other people, can lead to injury. **Regardless my participation in this Rodeo is purely voluntary and I elect to do so at my own risk. I expressly accept and assume all responsibility and risk (both known and unanticipated) to myself, to others, and to my property.**

In consideration for allowing me to participate, I voluntarily agree to release, discharge, and hold harmless the Kernville Chamber from all liability claims. These could be claims arising out of: negligence, recklessness, incorrect decisions, strict liability, breach of contract, or any act, in any way, associated with my participation. This release will also apply to any negligence in rendering (or not rendering) medical or emergency aid. I will hold harmless the Kernville Chamber, without limitation or reservation whatsoever, from any such liability, cost, expense, loss or damage. **In signing this document, I fully understand that if I (or any minor on whose behalf I am signing) am hurt, die, or have property damaged, I am giving up my right (and that of family members, heirs, and assigns) to make a claim or file a lawsuit against the Kernville Chamber, and all parties and affiliates of theirs, even if they negligently or by some other act (or omission) cause the injury.**

If necessary for the Kernville Chamber to incur attorney's fees or other costs to enforce any part of this agreement, I agree to indemnify and reimburse them for all fees and costs. If any portion of this agreement is judged invalid, the validity of the remaining portion(s) will not be affected. Legal disputes will be heard in Kern County under California law. **My signature below indicates I have read and now completely understand this document. I know that it affects my legal rights and I agree to be bound by its terms.**
